



Check in to the Weekly McLennan County ARES net every Monday at 8:00 PM on the 145.15 repeater (tone 123.0). If you have a sincere desire to help, registration is necessary before

the next emergency, not after it occurs. We are also beginning to include our 70 cm repeater 442.875 MHz (input at +5.0 MHz, tone 123 Hz).

Field Day

Field Day is this weekend June 27 and 28th. With the COVID-19 mess, HOTARC has decided to not do our normal Field Day. This gives each of us the opportunity to set up our own station or operate from our home

station. This year the ARRL has put in place a temporary rule allowing Class D stations to contact other Class D stations for points. This allows us to contact each other on simplex and we can use 2 meters or 70 cm to make those contacts.

I am proposing we use the following times and frequencies for VHF/UHF simplex.

Time Frequency 2:00 pm Sat 145.540 6:00 pm Sat 446.625 8:00 am Sun 145.540 12:00 pm Sun 446.625

Repeater Work

On Friday June 12, work was completed on the W5NCD tower in Eddie to replace all three antennas as the 400-foot level and to add two additional antennas at the 300-foot level. This replaces antennas that have been in

service for over 20 years.

the installation.

We now have three VHF antennas and two UHF antennas on this tower. Overall, the installation went very well and I am pleased with the results.

We did discover that the feedline that was previously used for the 145.15 repeater was damaged and indicated a high VSWR upon testing. The repeater was switched to one of the new antennas on the 300 foot level and is working well. At some point in the future, when a tower crew will be working on the tower anyway, we should consider replacing the feedline. There is not an immediate need to take any action at this point.
