ARES Update July 2019


It is again time for the 2-year ARES data update. This is done every 2 years in order to make sure that data is current and up-to-date.

I am in the initial stages of our ARES data update. This year I need each ARES member to complete a new ARES application – can be found on HOTARC's [ARES web page](#). Once I receive the application, I will make any required changes and issue a new ARES ID Card with a July 2021 expiration date.



Remember, all disaster response is being handled through the **Waco-McLennan County Emergency Management**. If you want to work disaster response, you will need to make an appointment with Elizabeth Thomas at Emergency Management (254-750-5911) for your required **annual background check and documentation of required training**. The basic training requirements are the same as have been required by ARES for involvement in actual disaster response but are now managed by Emergency Management. As I have said before, don't wait until the disaster happens to apply. You will be too late.

As I look over the names of the current ARES members, I see members of HOTARC that are not ARES members. I can't understand why every member of HOTARC is not a member of ARES. The price is right: FREE! All that's required is a valid amateur radio license and a willingness to help. If requested to assist in an event or emergency situation, participation is still voluntary. If you feel that you don't have the time and/or membership conflicts with the job, remember we may face a situation where your job is affected by the emergency, and/or things that normally occupy your time may, in fact, be cancelled! The ARES application asks your availability: 24/7, Nights & Weekends, or General. Pick the one that best suits your schedule.



A real emergency is going to take all the resources that we have, and after the event happens is **NOT** the time to join ARES. Remember those wanting to work disaster response must have completed four of the **FREE** FEMA courses below. (Click the links for more info and start the process today!)

- [IS-700.B \(NIMS\)](#) – Introduction to the National Incident Management System
- [IS-100.C \(ICS\)](#) – Introduction to the Incident Command System
- [IS-200.C \(ICS\)](#) – Basic Incident Command System for Initial Response
- [IS-800.C \(NRF\)](#) – Introduction to National Response Framework

Current Net Control operators are considered major players for disaster response and especially need to have completed the courses. Without these basic courses you will NOT qualify for access to secure and/or restricted locations which, again, are now managed by Emergency Management. Our support will most likely be needed in the Emergency Operations Centers, Incident Command Posts, Police or Fire facilities, and hospitals just to name a few. If you are not a member, go to hotarc.org/ares, fill out an application, send it in, and become a registered ARES member. I also have applications at all club meetings. Links to the FEMA Courses are also provided on the HOTARC web site.

Remember, it is not ****IF**** it will happen, but ****WHEN**** it will occur. As we've said often: It is better to be a small part of the solution rather than a big part of the problem. Get involved! You'll be glad you did.

2019 Waco Wild West is History!


The 2019 Waco Wild West is in the books. I would like to thank everyone that pitched in to make this happen. Whether it was staffing a rest stop, working Net Control, helping with trackers, setting up digipeaters, or working on the trailer. All your help made it possible! Thank you for contributing to [HOTARC's support of this special event](#).



This year's ride had several new twists. The most obvious was **eliminating the 100-mile course**. In addition to greatly simplified staffing and APRS infrastructure, it also meant we were all done about three hours earlier. Rather than waiting for riders to cross the finish line at 5:30 (typical of past years), our Net Control station was taken down and I was *home by 5:30!*

Another significant change this year was **using our 442.875 repeater** (rather than 145.15). It seems we had better coverage all over the course, and rest-stop folks could reliably use an HT to reach Net Control. Even from downtown, I was able to reliably work the repeater using just an HT! 442.875 MHz helped everyone remain connected to Net Control!

This event requires a wide-area digipeater. The W5NCD Bruceville-Eddy tower site is ideally situated and accessible. In years past, a trip to the repeater site a day or two before the event was required to swap antenna connections and power from the W5NCD 147.240 repeater to 147.500 gear (e.g., AC5JC's home digipeater), and after the event, a return trip to restore everything back to normal. Instead, this year, thanks to the **upgraded special events digipeater at the W5NCD tower site**, I simply connected via the internet and turned On the special event digipeater—remotely! W5NCD's repeater and AC5JC's home digipeater both remained undisturbed and online during the event. I was also able to activate and test the special event digipeater weeks before the event. This is a major modernization in capability for HOTARC!



We've learned that APRS special-event tracking works best when available to others via the Internet. That requires uploading real-time APRS data via "I-gates." **Two new digipeater/I-gate systems** were assembled and tested. One was deployed at the KC5UOZ workshop (Rest Stop 3), where it provided solid coverage of trackers moving along the "lollipop portion" of the 64-mile course. The second unit, based on one of HOTARC's new TH-D72a radios, was intended for Rest Stop 5 in Robinson. Lack of volunteers prevented this unit from being installed, but it's ready to go next time!

With the additional I-gates, shorter course, and fewer SAG vehicles, we employed a **higher beacon rate on the APRS trackers**, providing better resolution for each SAG location. We had several cases where Net Control was able to identify a SAG vehicle was located just a few blocks from a rider in distress.

Several new powerful HT's (two TH-D72a's approved for purchased by HOTARC members, two TH-D72a's provided by KC5UOZ and AE5CA, and three AT-D878's) allowed SAG vehicles and lead vehicles to not only **beacon tracking info via APRS, but also monitor all our Net communications**. This added situational awareness prompted several SAG drivers to telephone Net Control to offer their support.

Overall, the quality and performance of the HOTARC gear and manpower this year was superb. WE DID GREAT! I made some notes for things that can be done even better next year. Thanks again to everyone who helped in the 2019 Waco Wild West bike event!
